## Please note:

- **Include 3-4 pictures of the location where the ramp is to be constructed. Applications without pictures will NOT be considered. Photos should be taken within the last year, NO Google Maps Photos.**
- Applications indicate a desire to have a ramp added to the external entrance to the home and the understanding applicant will accept ramp if selected. Cancelling at the last minute denies someone else the opportunity to receive a ramp.
- Potential recipients, if not minors or severely disabled, **must** be aware of application— **NO SURPRISE RAMPS. Applicants must notify the recipient of the application and confirm that the recipient wishes to receive a ramp if the applicant is not the recipient.**

## HOMEOWNERS AGREEMENT AND RELEASE FROM LIABILITY

I understand a ramp will be built at my home between April 2025 and July 2025. However, the date may be changed, my home deleted from the project, or the project cancelled by the sole discretion of the Master Builders Association.
- Assumption of Risk.** I am aware that in participating in this project I may be exposed to personal injury or damage to my property as a result of the activities of the project volunteers or the conditions under which volunteer services are performed. I understand that all of the volunteers may not be skilled or licensed as contractors. I further understand that the work on my home may not be completed by the volunteers. With knowledge of these dangers, I agree to accept any and all risks of personal injury, damage to my property, loss of use, and economic consequence.
- Release.** In consideration of the opportunity afforded me to participate in this project, I hereby agree that I, my assignees, heirs, guardians, and legal representatives will not make any claim with respect to any work performed or materials provided against Master Builders Association of King and Snohomish Counties or against any of the affiliated/organizations or either of their officers or directors or the supplier of any materials or equipment that is used by the project or volunteers. Without limiting the generality of the foregoing, I hereby waive and release my rights, actions, or causes of action resulting from known or unknown property damage, personal injury or death to me, loss of use, or economic consequence, sustained in connection with my participation in the project.
