





2018 was another strong year for MBAKS and our nearly 3,000 member companies. We expanded our reach in the homebuilding industry and built upon our reputation as experts in regional growth. Just a few of the 2018 highlights: the MBA Health Trust insured more than 37,000 individuals, GRIP refunded \$12 million to program participants, and Built Green continued to set new standards for sustainable home construction. 

2018 RETROSPECT



MEMBERSHIP VALUE

MBAKS **successfully defended** against significant threats to the **MBA Heath Trust** which provided **37,000** men, women, and children affordable, comprehensive health insurance.

GRIP, MBAKS' retro program, grew to \$64.5 million and L&I refunded just over \$12 million to be distributed to 1,100 participant companies.

MBAKS' membership retention rate for 2018 was 85 percent.











COUNCIL HIGHLIGHTS

MBAKS council events attendance increased 16 percent over 2017.

REX/T-REX, our remodelers excellence awards program, saw a **20 percent increase** in entries and increased event attendance.

The Professional Women in Building Council increased membership by 20 percent.



COMMUNITY

Rampathon celebrated 25 years this year. A record 47 ramps

were provided to families and individuals in need in 2018.

Built Green, our green home certification program, certified **1,058 projects** with 2,426 total units in 2018. There are now a total of **2,266 projects** enrolled, comprised of 4,163 units.

Built Green completed operational memorandums of understanding to provide certification to **Kitsap HBA and BIA Whatcom members.**











HOUSING ADVOCACY

MBAKS successfully lobbied the Department of Ecology to adjust evaluation of wetland buffers in many instances to allow for setbacks of 40 feet versus the prior 150 feet.

MBAKS worked to ensure that Snohomish County Council **voted to vest school district impact fees**, removing uncertainty growing impact fees were creating for homebuilders.

The Affordable Housing Council helped **26 of 34 endorsed candidates win their races** and launched an independent expenditure to support **Snohomish County PUD commissioner Sid Logan**, who won with 60 percent of the vote.












FINANCIAL STEWARDSHIP

2018 revenue exceeded the budget by 10 percent, totaling \$10.6M for the year. Expenses were **five percent below** budget.


An Unqualified (Clean) Audit Report on 2017 Financial Statements was delivered **within 45 days** from year end.

The **Affordable Housing Council contribution model** was deployed across all membership, resulting in more than \$130K in additional funding for the PAC and tax savings of \$27K.
